Great Western Recycling only collects personal data for business purposes. We use the GDPR and ICO definition of 'personal data' which means any "information relating to an identifiable person who can be directly or indirectly identified in particular by reference to an identifier". The categories of personal data we collect, and use are:

- Names and surnames
- Business email addresses
- Business phone numbers
- Business addresses
- Direct Debit Details

We collect your personal data in various ways such as a cold call or a meeting where you give us your contact details, approaching you on Linked In or by being introduced by someone else. When a new customer joins Great Western Recycling, we collect various information about you for our contract purposes.
